 - To put in the slab, water supply & power will probably be around \$10,000.00
 - The 55 x 35 ft pad 1 ft thick, move garden shed and propane tank \$6,000.00
 - Electric estimate \$2,500.00
 - Ramp & sidewalk \$3,000
 - remove tree, redress driveway with base rock & new gate \$5,000.00
 - Move and set up portable classroom \$5,850.00
 - Inspection & application fees \$1500.00 to 1,800.00
